2020's MPRCA Campaign Was Not a Complete Loss

I know there's been a lot of questions, rumors going around and overall concern as to what happened during the campaign and lawsuit as well as where do we go from here. First, MPRCA will not be on the 2020 Ballot in November. And second, we will not be able to use the signatures from this year's canvassing efforts in 2022. Its unfortunate the campaign ended on such harsh terms with the threat of a global pandemic especially when it felt like success was so close. The lawsuit took a drastic turn when teams involved were forced to sign off due to a miscalculation of signatures on top of lack of finances.

Before I begin to explain where we go from here allow me to thank all the teams involved with managing the campaign on both sides of the wall. You all did a wonderful job! Many individuals worked tirelessly to ensure this campaign gained as much traction as possible. Many sacrificed countless hours of their time, energy and resources to make this happen. This was not a loss! We can't thank you enough for the inspiration. Your efforts restored hope to the hopeless, became a medium for the voiceless to speak, and you all put into concrete form dreams that were abandoned. As with anything in life there will always be trial and error, despite that we put up a damn good fight! Experience is the best teacher, are there things we could've done different? Yes, but we learned a lot over the past year. We will succeed in 2022 no doubt! We stood tall against a giant, we did not fall and we will not fail! Our strategy and plan of action is clear and we will prevail.

We need to keep our spirits high, our efforts were not in vain. Although we didn't make the 2020 ballot, look at the positive things we accomplished and all that transpired through this MPRCA campaign and overall good time movement. Since 1998 when TIS was first enacted people have been making efforts to repeal this harsh form of punitive law. After two decades, the movement for good time was completely dead. The talk of getting good time back was so farfetched when we initially began to talk about it, every organization SawariMedia reached out to told us it was a waste of time. We literally had no support whatsoever, but we continued moving forward despite the odds. Our efforts have now revitalized and resuscitated what initially appeared to be a lost cause. Organizations from all over the country are now in full support and now we also have multiple state House and Senate committee members helping us make progress. We have a wide range of possibilities and opportunities ahead of us.

However, one thing we learned the hard way is that finances are a critical factor in succeeding in any form of campaign or movement

By all means this is a peoples movement, therefore anytime we start a peoples movement then we have to claim accountability for sustaining and generating the funds to sustain it. Campaigns are not cheap and depending on the magnitude of such movements it could take hundreds of thousands (if not millions) of dollars to successfully run a campaign. We're not a government paid or corperate ran campaign so all of our funds to sustain the campaign were personal donations. On behave of all incarcerated citizens we thank all the families, friends and love ones who donated what they could to ensure this campaign stayed alive and funded for as long as it did. As well as all the other organizations who assisted.

To the volunteers who were one of the most important aspects of the movement, we thank you deeply. Although a lot people showed support by signing petitions, we needed more people willing to help canvass. Our canvassing teams were short because we lacked proper funding to compensate the canvassers. We appreciate the sacrifice of every person who volunteered, collected signatures and informed people of the campaign. We needed more people like those who were willing to show up whenever its time to work.

I know a lot of people are upset with the end results, I feel the same. To be practical, we can't expect immediate results. Trying to change legislation that's been the fabric of the state system for more then 20 years is not an easy task. For us to come this close our first time around speaks volumes to the power we have as a people to propell the initiative forward in the fight for change. We did a great job and its not over. The Law Makers of Michigan know they will have their work cut out for them next time around. We will see our desired results, if not in 2020, then 2022 is a definite!

What we can do now and where we go from here...

There's a Senator named Jeff Irwin who plans to introduce a Bill to repeal TIS by the beginning of 2021. We should follow that bill-closely and combine our efforts with supporting him. His Bill has the potential to aid in the process of truly repealing TIS. To support this bill we'll start a letter writing campaign to committee members who would vote on this legislation. That's the most practical next immidiate step to keep moving forward.

Last but not least, the most important thing that we can do from the inside is to not lose hope. We must continue to stay informed and keep in contact with outside organizers. Select MPRCA canvassers are reorganizing to launch a nonprofit to host a petition for collectting signatures for the 2022 ballot. Until that's set in place make sure to inform your family, friends and love ones to remain in contact with the Motivate Michigan Facebook page so we can continue building the network for 2022. By preparing for these things now then come 2022 the process of getting our bill on the ballot will be a walk in the park.

We are the movement for the people, so family, friends, love ones and any organizations out there looking to help, the time is now we have to stay ahead of this for future productivity. P.E.A.C.E...

Make sure you submit your paper form as soon as possible to beat the October 30th deadline. This sample EIP 1040 form was developed by Lieff Cabraser, the law firm handling the court case, to assist incarcerated citizens with filing the information necessary to the IRS for pandemic stimulus funding. Paper copies of this 1040 form should be available to you at your facility. The highlighted portions are the only parts of the application that need to be completed. Any dependants that you have most likely have already been claimed by your partner or otherwise legal gaurdian. As of right now the IRS' only deduction from stimulus checks are overdue child support payments, no other deductions are made by the IRS than from stimulus check money. Make sure to verify with staff at your facility 1. Will any fees be deducted from your stimulus check if it's mailed to you there? 2. Will there be any delays in processing your check into your trust account? Unfortunately, some facilities are holding checks rather than immidiately placing them into the prisoners' account. You can avoid this delay or potential deducations by the prison administration if you have an outside bank account to include in section 20, this would allow for your stimulus payment to be deposited directly into that account and avoid your check being mailed to and intercepted by the facility. If you do not have an outside bank account you can have someone setup an online banking account using your SSN and a permanent address, some online banking options that incarcerated citizens have used successfully include Cash App, Venmo and Chime. If you are having trouble setting up an online account then you can have your stimulus check mailed to the permanent address where you'd like to link your bank account while you work on setting it up. The account setup should be completed by the time the check arrives to be deposited. Please be careful with who you share your SSN and other sensative information to, make sure your either working with someone you trust or a trusted organization to assist you with online filing your application.


